iv)	Any loss of life or property due to non-functioning of fire safety measures and other installations shall be the responsibilities of the management.			
v)	All occupants / security personnel shall be trained to operate the fire safety equipments during Emergency.			
vi)	Addition / alteration, if any in the building may be verified by building authority.			
vii)	Mock drills should be conducted once in 3 months for initial two years Thereafter, once in every 06 months.
